

Private Label Licensing Information for OCIA-Certified Processors/Handlers

Thank you for your interest in OCIA International's Private Label Registration Program. This program provides a streamlined option for Private Label Registrants to have their labels affixed to organic products handled by an OCIA-certified Processor/Handler, without requiring separate organic certification for the Registrant.

Program Overview

Under the NOP and OCIA International Standards, the name of the certified facility that processed/handled the product last must be listed on the label. OCIA's Private Label Registration allows Registrants to use their branding while ensuring that all organic handling remains under the control of an OCIA-certified Processor/Handler. The Processor/Handler is the only facility authorized to apply OCIA registered trademarks, names, and/or seals—the Private Label Registrant may not use or apply the seal independently.

Key Benefits & Cost Savings

- No additional certification required for Private Label Registrants
- No separate inspection required for Private Label Registrants
- ✓ Lower fees—only a registration fee paid by the OCIA-certified Processor/Handler
- Simple annual renewal process

Private Label Registration Fees

	Annual Fee (up to 10 brands)	Additional Label Review Fees
Direct Associates		\$50 per single-ingredient label, \$100 per multi-ingredient label (outside renewal cycle)
Chapter Members		\$50 per single-ingredient label, \$100 per multi-ingredient label (outside renewal cycle)

For the initial submission, OCIA will invoice the total fee after the product/label review is complete. Upon annual renewal, OCIA will charge the annual fee above plus user fees on the sale of the product by the OCIA-Certified Processor/Handler, or from the fees received from the registrant.

Label Requirements

The statement "Certified Organic by OCIA" must be included on the label under the name of the Private Label Registrant following applicable organic standards compliance requirements. No additional information may be placed between the company name and this statement.



Required Documentation for Registration

The OCIA-certified Processor/Handler is responsible for collecting and submitting the following documents annually:

- 1. Private Label Licensing Agreement
- 2. Private Label Licensing Annual Application
- 3. Private Label Registrant Form
- 4. Exempt Handler Affidavit (EHA) required for NOP certification
- 5. Copies of all labels from the Registrant using the OCIA name, seal, or logo
- 6. Business Relationship Letter detailing the business relationship and responsibilities between the OCIA-certified Processor/Handler and the Private Label Registrant, with supporting documentation

This documentation must be submitted with the certification application annually for each Private Label Registrant.

Ongoing Compliance & Maintenance

- ✓ Annual Renewal Registration must be renewed each year with updated documents and applicable fees.
- ✓ Notification of Changes The Processor/Handler must immediately report any changes to labels, management, ownership, or business relationships.
- ✓ Inspection Verification The Processor/Handler must maintain all ingredient and processing records, which will be reviewed during OCIA's annual inspection.

Eligibility Criteria

Private Label Registration is only available for specific situations. The OCIA-certified Processor/Handler must handle all purchasing, processing, and labeling. The Private Label Registrant cannot take ownership of the product before it is in its final consumer package.

If the Registrant:

- \times Purchases, owns, or controls the ingredients \rightarrow They must be certified
- \times Controls the manufacturing process \rightarrow They must be certified
- \times Handles the product before final sealed packaging \rightarrow They must be certified

For NOP certification, the final product must be sealed in tamper-evident packaging. If not, the Registrant must become certified as a Broker/Trader or Processor.

Private Label Registration Eligibility Checklist

1. Whose name is on the label?

- If the **OCIA-certified Processor/Handler** is listed on the information panel as the distributor or handler of the final product (i.e., OCIA-certified Processor/Handler's name appears directly above "Certified Organic by OCIA" statement on product information panel), Private Label Registration is not required.
- If the **Private Label Registrant** is identified on the information panel as the distributor or handler of the final product, and they are not certified with OCIA, Private Label Registration is required.

2. Who purchases, owns, and selects the ingredients?

If the **Private Label Registrant** ever purchases, owns, or chooses the ingredients, they are **not eligible** for Private Label Registration and must become certified to use the OCIA name, seal, or logo.

3. Who controls the manufacturing process?

- The OCIA-certified Processor/Handler must control all aspects of production, including labeling.
- If the **Private Label Registrant** controls the manufacturing, Private Label Registration is not allowed.

4. Are ingredient and processing records maintained?

- The OCIA-certified Processor/Handler must maintain complete records to allow verification during inspections.
- If records are not maintained, Private Label Registration cannot be granted.

5. For NOP products, is the final product in sealed, tamper-evident packaging?

• If the answer is **no**, the Private Label Registrant must obtain certification.
